SUBJECT: Florida's Registered Sexual Predator/Offender Listing

The Florida Department of Law Enforcement (FDLE) has now made available a listing of Florida's Registered Sexual Predator/Offender via a direct electronic transfer process. Requestor's will have the ability to generate a file of Sexual Predators/Offenders by county, multiple counties, or the entire list manually or create an electronic process to extract this list. Please note that information regarding sexual offenders and predators is amended by FDLE on a continuous or daily basis as and when needed for accuracy, currency, and completeness. These amendments update the FDLE Sexual Predator/Offender Internet Site in a Real Time basis. Consequently this listing, particularly with reference to addresses and named individuals, is only updated every four hours and is obsolete as soon as the file is generated. In the future, FDLE will be adding additional fields to this file. We will post the new amendments and the new layouts prior to implementation.

FDLE strongly recommends that the following warnings be included on any subsequent dissemination of the information.

- 1) Positive identification cannot be made without a fingerprint comparison; and**
- 2) This information is provided as a service for the public's benefit and may not be used in the perpetration of any criminal act or harassment against these individuals.**
